AIMS OF THE WORKSHOP

The Public Administration is the main actor in making strategies for economic and social development and this role is confirmed by the efforts underway in several countries which take PA as playing a central role in the dynamics of crisis and stagnation, with spill over effects on business and families.

Policies and intervention programs of the major international institutions and of many countries are recognizing the primary importance of the public administration and management; this recognition goes hand in hand with the need to improve their productivity, to evaluate and measure performances, and with capacity building efforts of public governance, considered the ability of the Public administration itself, to coordinate and govern effectively the systems and the networks of economic and social actors.

In this context, scholars of public management can offer a significant contribution to understanding under what conditions and with what instruments the public administration can contribute to the definition and implementation of a model of sustainable economic growth.

The Fourth National Workshop of the Azienda Pubblica Journal will include a plenary session, six parallel sessions and a round table discussion. In addition, there will be organised a seminar dedicated to the presentation of research papers by young researchers and PhD candidates.

Papers should adopt a strong theoretic and empirical methodological approach. Therefore, for each of them should be clearly defined:

- The theories and the reference literature
- The purpose and the contribution to the advancement of knowledge (objectives and research questions)
- Research methods
- The critical discussion of results
- Implications for policy making and practitioners

The same requirements apply to the synthetic abstracts.

PARALLEL SESSIONS

The following issues will be discussed in the themed sessions:

1. Accountability systems for the quality and transparency of the information and operations of Public Administrations.
2. Measurement and evaluation of performance (efficiency, effectiveness, equity, ethics).
3. Standards of services and standards of costs in a federal system.
4. Productivity of the Public Administration as a lever for the economic recovery and the sustainable development of economic and social systems.
5. Public enterprises and public utilities: best practices and governance systems.

THE ROUND TABLE

The round table will be devoted to the debate between public administration scholars, practitioners and policy makers. It will highlight the salient features of the research and training and the main drivers of the model of sustainable growth.

Speakers will be invited from the country's major public institutions, including the Ministry of Economy and Finance, the Department of Public Administration, the Court of Auditors, the Conference State - Regions, ANCI, CNEL and Training Schools.

WORKSHOP SEMINAR DEDICATED TO THE PHD STUDENTS

In the afternoon of March 26th, a seminar dedicated to young researchers and PhD students will be organized. The seminar is an excellent opportunity for young scholars of business and public administration who want to improve their research skills and be part of a larger community. REQUIREMENTS FOR THE ABSTRACT AND PAPERS

Only one paper can be submitted, as author or co-author, with these features:

- Abstract: Maximum 800 words-Times New Roman 12, Word.
- Paper: Maximum 8000 words-Times New Roman 12, Word.

SELECTION

The selection includes two phases of anonymous peer review, according to the Azienda Pubblica Journal editorial norms. The first selection will be made by the Scientific Committee through the evaluation of the abstract. In the second phase, from the review of the final papers will be

selected those to be presented and discussed at the workshop. The accepted papers will be published in the Azienda Pubblica Journal, following the usual peer review procedures.
