Corporate Social Responsibility is an increasingly relevant topic in the current economic context. The rise of pressures and opportunities driven by the sustainability makes particularly interesting the interplay among management, sustainability and social impacts for both scholars and practitioners.

In line with these considerations, the Workshop aims to address the opportunities, criticalities and the future perspectives in the studies on Corporate Social responsibility for increasing firm performance and growth.

Perspectives from different fields are encouraged. The workshop aims to promote interaction and discussion, and to develop research networks among scholars working in accounting and management studies.

Participants of the SIW will have the opportunity to interact with foreign and Italian faculty members and to discuss with two influential scholars on the themes addressed in the Workshop: **Prof Stewart Smyth** and **Prof. Pablo Rodrigo**.

A non-exhaustive list of possible topic areas includes the following:

- environmental Auditing;
- environmental risk management;
- corporate governance and CSR;
- ethical issues related to business;
- sustainability in management accounting systems;
- CSR and corporate reporting;
- non-financial disclosure;
- innovation and sustainability;
- sustainability management tools;
- sustainable business models;
- sustainability strategies;
- sustainability in public administration;
- sustainability in non-profit organizations;
- environmental strategies;
- sustainability in accounting history.

Both theoretical and empirical studies are encouraged. Scholars and practitioners are invited to submit unpublished papers and research proposal.

Full papers must not exceed 8.000 words including abstract, keywords, tables, figures and references.

Research proposal must not exceed 4.000 words including abstract, keywords, tables, figures and references.

All submissions should be double-spaced, utilized size 12 Times New Roman font, and be in English. All submissions will be subject to a double review process by the organizing committee and anonymous reviewers.

Registered papers will be included in the conference proceedings with ISBN number

### **Important dates**

The deadline for submission of full papers and research proposals is October 13th, 2019.

Notification of acceptance will be sent by 28 October.

Registration is required no later than October 31th, 2019.
